La Paloma Academy offers healthy meals every school day and follows the nutrient standard menu planning system. Breakfast will be served <u>in the classroom</u>. Lunch and breakfast menus are available in the school office. Breakfast is FREE; the cost for lunch is <u>\$2.85</u> a day. The lunch price is subject to change according to federal regulations. Your children may qualify for free lunch meals or for the reduced price of \$.40 per meal. The food service staff will <u>ONLY</u> make food or milk substitutions or modifications for students with disabilities. Substitutions or modifications for students with disabilities must be based on a prescription written by a licensed physician. Please contact the Food Service office for more information.

Please remember that it is the parent's responsibility to make sure that the Food Service manager receives your application. A new application must be completed each school year. Students with approved applications on file from the previous school year, and any additional siblings will receive the same free or reduced-price meal benefits until a new application is received and approved. **ALL** NEW Applications must be received by **September 13, 2018**. After that, any family who has not submitted a new application will have their meal benefits terminated and will be charged **\$2.85** per meal. Each application can take up to 10 days to process. If you have sent in your application and do not receive a letter of approval within 10-14 days, please call Teri Brown at (520) 733-7373 ext 405. Please remember, for a faster response time it is best to submit the application as early as possible and not on the first day of school. On average, we process more than 1,000 applications at the beginning of each school year. If you prefer to mail in your application, you may send it to the following address:

We urge you to take advantage of our prepayment plan. Also, you may place money in your child's account at any time either online at <u>myschoolbucks.com</u> or the school office. We strongly encourage payment by check because it is the most secure way to transport payment between the home and school. Students may be extended up to 3 meal loans to be repaid immediately by the parents. Parents will be advised of a student loan by written notice that is sent home with the student from the school's cafeteria. If you take advantage of our prepayment plan and your child's account is running low, we will place a stamp on your child's hand for grades Kindergarten through 2nd grade as a reminder that your child needs lunch money. Dear Parent/Guardian:

Children need healthy meals to learn. **La Paloma Academy** offers healthy meals every school day. **Breakfast is free**; lunch costs \$2.85. Your children may qualify for free meals or for reduced-price meals. Reduced-price is \$.40 for lunch. This packet includes an application for free or reduced-price meal benefits, as well as a set of detailed instructions. Below are some common questions and answers to help you with the application process.

1. WHO CAN GET FREE MEALS?

- a. All children in households receiving benefits from **SNAP**, **FDPIR** (**Food Distribution Program on Indian Reservations**) or **TANF**, can get free meals regardless of your income.
- b. Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
- c. Children participating in their school's Head Start Program are eligible for free meals.
- d. Children who meet the definition of homeless, runaway, or migrant are eligible for free meals.
- e. Children can get free or reduced-price meals if your household's gross income is within the limits on the Federal Income Eligibility Guidelines. Your children may qualify for free or reduced-price meals if your household income falls at or below the limits on this chart.

- 2. HOW DO I KNOW IF MY CHILDREN QUALIFY AS HOMELESS, MIGRANT, OR RUNAWAY? Do the members of your household lack a permanent address? Are you staying together in a shelter, hotel, or other temporary housing arrangement? Does your family relocate on a seasonal basis? Are any children living with you who have chosen to leave their prior family or household? If you believe children in your household meet these descriptions and haven't been told your children will get free meals, please call 520-733-7373 ask for **homeless liaison or migrant coordinator**.
- 3. DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. *Use one Free and Reduced-Price School Meals Application for all students in your household.* We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to: **La Paloma Academy, 8140 E. Golf Links Rd., Tucson, Arizona 85730, Attn: Food Service.**
- 4. SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE APPROVED FOR FREE MEALS? No, but please read the letter you got carefully. If any children in your household were missing from your eligibility notification, contact **520-733-7373** immediately.
- 5. CAN I APPLY ONLINE? No. Our district does not have the option to apply for free or reduced-price meals online at this time. Please contact **Teri Brown at 520-733-7373 ext. 405** and refer to the information above to complete a paper application.

- 6. MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT ANOTHER ONE? Yes. Your child's application is only good for that school year and for the first few days of this school year through **September 13**, **2018**. You must send in a new application unless the school told you that your child is eligible for the new school year. If you do not send in a new application that is approved by the school or you have not been notified that your child is eligible for free meals, your child will be charged the full price for meals.
- 7. I GET WIC. CAN MY CHILD(REN) GET FREE MEALS? Children in households participating in WIC <u>may</u> be eligible for free or reduced-price meals. Please fill out an application.
- 8. WILL THE INFORMATION I GIVE BE CHECKED? Yes. We may also ask you to send written proof of the household income you report.
- 9. IF I DON'T QUALIFY NOW, MAY I APPLY LATER? Yes, you may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced-price meals if the household income drops below the income limit.
- 10. WHAT IF I DISAGREE WITH THE SCHOOL'S DECISION ABOUT MY APPLICATION? You should talk to school officials. You also may ask for a hearing by calling or writing to: La Paloma Academy, 8140 E. Golf Links Rd., Tucson, Arizona 85730, Attn: Food Service.
- 11. MAY I APPLY IF SOMEONE IN MY HOUSEHOLD IS NOT A U.S. CITIZEN? Yes. You, your children, or other household members do not have to be U.S. citizens to apply for free or reduced-price meals. Our organization does not release information for immigration-related purposes in the usual course of operating the School Nutrition Programs.
- 12. WHAT IF MY INCOME IS NOT ALWAYS THE SAME? List the amount that you <u>normally</u> receive. For example, if you normally make \$1,000 each month, but you missed some work last month and only made \$900, put down that you made \$1,000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
- 13. WHAT IF SOME HOUSEHOLD MEMBERS HAVE NO INCOME TO REPORT? Household members may not receive some types of income we ask you to report on the application, or may not receive income at all. Whenever this happens, please write a 0 in the field. However, if any income fields are left empty or blank, those will also be counted as zeroes. Please be careful when leaving income fields blank, as we will assume you meant to do so.
- 14. WE ARE IN THE MILITARY. DO WE REPORT OUR INCOME DIFFERENTLY? Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food, or clothing, it must also be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment is also excluded from income.
- 15. WHAT IF THERE ISN'T ENOUGH SPACE ON THE APPLICATION FOR MY FAMILY? List any additional household members on a separate piece of paper, and attach it to your application. Contact **La Paloma Academy, 8140 E. Golf Links Rd., Tucson, Arizona 85730, Attn: Food Service** to receive a second application.
- 16. MY FAMILY NEEDS MORE HELP. ARE THERE OTHER PROGRAMS WE MIGHT APPLY FOR? To find out how to apply for **SNAP** or other assistance benefits, contact your local assistance office or call 1-800-352-8401.

List all household members who are infants, children, and students up to and including grade 12. This should include all children who live in your household. They do not have to be related to you to be part of your household.

List the first name, middle initial, and last name of each child. List one name per line, and write one letter in each box. Stop if you run out of space. If you need additional lines, attach a second piece of paper with all required information for additional children.
